

Part A – Flexischools BridgeClimb Competition Details

The terms and conditions for this BridgeClimb competition (**Competition**) are comprised of the details in Part A below and the related terms and conditions set out in Part B (together the “**Terms**”).

Who may enter	Entry is open to individuals over 18 years of age and residing in New South Wales, Australia, who complete and submit their personal details in accordance with the “how to enter” section below (Eligible Entrants). Employees, immediate family members of employees, employees of any company associated with the Promoter are ineligible to enter.
How to enter	To enter, Eligible Entrants must complete and submit the competition entry form, available online at Vision 6 and provide relevant personal contact details, which the Promoter will use to contact the Eligible Entrant. By entering the competition, you agree that your personal information will be collected by the Promoter, and used in accordance with the Privacy Policy . Entering the competition is free of charge.
Prize(s)	There will be one (1) winner. The winner will be awarded the following prizes: <ul style="list-style-type: none"> one (1) Family pass (two adults and two children, 8-15 years) to a “BridgeClimb Unlocked” Day climb experience; and one (1) Deluxe Sydney Harbour Bridge Nano Block set. Climbers must be at least 8 years of age and physically fit. An 8 to 15 year-old Climber must be accompanied by an adult Climber.</p> <p>The prize cannot be transferred, exchanged or redeemed for cash. If a winner is drawn at that time, they will be contacted by phone and in writing within two (2) business days of the draw.</p>

Part B - Terms & Conditions for Flexischools BridgeClimb Competition

1. These “terms & conditions” contained in Part B apply to the Competition of chance described in Part A. Capitalised terms not otherwise defined in this Part B will have the meaning given to them in Part A.
2. The Competition will be conducted by the Promoter during the Competition Period specified in Part A.
3. The Terms may be amended or replaced by the Promoter in its absolute discretion and at any time. Any amended terms will be posted online at www.flexischools.com.au.
4. Entry into the Competition as described in Part A is deemed acceptance of the Terms (as amended from time to time).
5. Entry is open only to residents of New South Wales, Australia who comply with the additional entry restrictions specified in Part A.
6. To enter the Competition, the entrants must, during the Competition Period, follow the entry method and instructions specified in Part A.
7. Each entrant is responsible for notifying the Promoter of any changes to his/her email address or phone number during and after the Competition Period.
8. In accordance with Part A, the Competition is a game of chance and each validly submitted entry will enter the draw to be randomly selected by the Promoter as a Competition winner.
